


- (i) The State Government reserves the right to withdraw the above certificate at any time if the management fails to comply with the instruction of the State Government such as illegal removal of the teachers, non-payment of salaries to the teaching and non-teaching staff as per the approved scales etc.
- (ii) Admission should be made with the bonafied date of birth certificate.
- (iii) The trained teachers should replace all Un-trained teachers.
- (iv) The management should collect the tuition fee and special fee etc. as prescribed by Government from time to time.
- (v) The strength in classes should be as per rules in force.
- (vi) The management should follow the State Syllabus for Classes from I to V.
- (vii) The School should follow the three-language formula.
- (viii) The District Educational Officer or his nominee should be invited when the management makes recruitment of candidates for various categories of posts.
- (ix) Staff salaries should be paid as per Government Scales of pay.
- (x) Various facilities including infrastructure, play area etc. should be provided as per prescribed norms.
- (xi) The management should not collect donations either from the students or parents for admission.
